

## FIND HAWKA & HIS MATES 2025 TERMS & CONDITIONS

- 1. 'Find Hawka & His Mates 2025' (Promotion) commences at 9.00am AEST on Monday 2 June 2025 and concludes at 11.59pm AEST on Sunday 13 July 2025 (Promotion Period).
- 2. The promotion is promoted by Launceston Central Inc. (Promoter) Level 1, 63 65 Cameron Street in Launceston, Tasmania.
- 3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

## THE PRIZE

- 4. The Prize Pool consists of:
  - a) Two (2) tickets to each of the three (3) Hawthorn Hawks home games to be played at Launceston's UTAS Stadium on the following dates:
    - i. Friday 13 June 2025 vs. Adelaide Crows the Prize for this match is two (2) general admission tickets.
    - ii. Saturday 28 June 2025 vs. North Melbourne the Prize for this match is two (2) seated tickets.
    - iii. Saturday 19 July 2025 vs. Port Adelaide the Prize for this match is two (2) seated tickets.

To clarify, one (1) Prize comprising two (2) tickets will be drawn for each match, with the type of ticket varying for each match, as specified above.

- 5. The Prizes will be drawn on the Monday prior to each of the specified home games, on:
  - a) Monday 10 June 2025;
  - b) Monday 23 June 2025; and
  - c) Monday 14 July 2025.
- 6. The Winners will be selected at random by a staff member of the Promoter and all Entries must abide by Terms and Conditions to be eligible.
- 7. The Winners will be advised by phone and/or email on the day of the draw and will have until midday on the Friday prior to the game to collect their Prize from the Promoter. The onus is on the Winner to ensure they collect their Prize during the Promoter's office hours, prior to the match date.

  - c) Submit an Entry by completing a digital entry form with the following details:
    - Name the correct business in whose shop each player/Hawka can be found; and
    - Full name and contact details of the Entrant.



- 10. Entries can be made up until 11.59pm AEST on Sunday 13 July 2025.
- 11. Entries to the Promotion are limited to one per person.
- 12. All Entries received during the Promotion Period are eligible for all Prize draws.
- 13. Entries containing rude, vulgar, or otherwise inappropriate content will be deleted and will not be considered a valid Entry for the purposes of the Promotion.
- 14. The Entrant is responsible for ensuring their Entry is submitted and valid.
- 15. By entering the Promotion, the Entrant agrees to the Terms and Conditions.
