

# Find Santa's Reindeer

## TERMS & CONDITIONS

1. The Christmas in the City Find Santa's Reindeer Competition (Promotion) commences at 9.00am AEDT on Monday 25 November 2024 and concludes at 11.59pm AEDT on Sunday 22 December 2024 (Promotion Period).
2. The Promotion is promoted by Launceston Central Inc. (Promoter) Level 1, 63-65 Cameron Street, Launceston, Tasmania.
3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

### The Prizes

4. Prizes will be awarded to first, second, and third place Winners and will consist of:
  - a. First prize will consist of voucher from Paint the Town Red, to the value of \$200.
  - b. Second prize will consist of a voucher from Tidal Café, to the value of \$100.
  - c. Third prize will consist of a voucher from Smiggle, to the value of \$50.
  - d. The Prizes are sponsored by the Promoter.
  - e. The Prizes will be drawn at the conclusion of the Promotion, on Monday 23 December 2024.
  - f. First, second, and third place Winners will be selected at random by a staff member of the Promoter and entries must abide by Terms and Conditions to be eligible.
  - g. The Winners will be advised by phone and/or email on the day of the draw by 5.00pm AEDT on Monday 23 December 2024 will have 30 days to collect their Prize from the Promoter.
  - h. All Prizes must be used in conjunction with the Terms and Conditions set out in any vouchers provided and cannot be redeemed for cash.
  - i. The decision of the Promoter is final.

## How to enter

5. To enter the Promotion, Entrants must, during the Promotion Period:
  - a. Find each of the six (6) reindeer decals hidden in the windows of participating businesses within the Launceston Central Core Service Area; and
  - b. Access a digital entry forms via either:
    - i. The Launceston Central website, [www.launcestoncentral.com.au](http://www.launcestoncentral.com.au); or
    - ii. The Storytowns app, available via the QR code shown on posters, signage, and advertising materials for the Promotion; and
  - c. Submit an Entry by completing a digital entry form with the following details:
    - i. Name the correct business in whose shop window each reindeer can be found; and
    - ii. Full name and contact details of the Entrant.
  - d. By entering the Promotion, the Entrant agrees to the Terms and Conditions.
  - e. Entries can be made up until 11.59am AEDT on Sunday 22 December 2024.
  - f. Entries to the Promotion will be limited to one per person.
  - g. The Entrant is responsible for ensuring their Entry is submitted and valid.
  - h. Entries containing rude, vulgar, or otherwise inappropriate content will be deleted and will not be considered a valid entry for the purposes of the Promotion.

## General terms and conditions

6. No responsibility will be accepted for late, lost, incomplete or misdirected Entries. The Promoter reserves the right in its sole discretion to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such a person are reserved.
  - a. Proof of identity will be required to claim any prize.
  - b. If any Winner is under 18 years of age, the Prize will be awarded to the Winner's nominated parent/guardian upon presentation of photo identification. The parent/guardian shall be deemed the Winner for the purposes of these terms and conditions.
  - c. All Entrants under the age of 18 must have prior consent from their parent or guardian before entering the Promotion and must be able to provide evidence of such consent on request.
  - d. By entering the Promotion, the Entrant hereby gives the Promoter authority to publicly announce their name (should they be a Winner) at the time of the Selection and at any stage thereafter.
