

CHRISTMAS WINDOW COMPETITION

Terms and Conditions

- 1. The Christmas in the City Christmas Window Competition (Promotion) commences at 9.00am AEDT on Monday 20 November 2023 and concludes at 4.00pm AEDT on Thursday 21 December 2023 (Promotion Period).
- 2. The Promotion is promoted by Launceston Central Inc. (Promoter) Level 1, 63-65 Cameron Street, Launceston, Tasmania.
- 3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

The Prize

- 4. The prize will consist of:
 - a. A voucher to Launceston's Princess Theatre, to the value of \$150.
 - b. The Prize will be drawn at the conclusion of the Promotion on Friday 22 December 2023.
 - c. The Winner will be selected at random by a staff member of the Promoter and entries must abide by Terms and Conditions to be eligible.
 - d. The Winner will be advised by phone on the day of the draw by 5.00pm AEDT on Friday 22 December 2023 will have 30 days to collect their Prize from the Promoter.
 - e. The Prize must be used in conjunction with the Terms and Conditions set out in any vouchers provided and cannot be redeemed for cash.
 - f. The decision of the Promoter is final.

 - b. Post the photo to their social media account on either Facebook or Instagram along with the hashtag #LaunnieChristmas2023.
 - c. By entering the Promotion, the Entrant agrees to the Terms and Conditions.
 - d. Entries can be made up until 4.00pm AEDT on Thursday 21 December 2023.
 - e. Entrants may make more than one Entry.
 - f. The Entrant is responsible for ensuring their Entry is submitted and valid.
 - g. Entries containing rude, vulgar, or otherwise inappropriate content will be reported to the social media platform upon which they are posted and will not be considered a valid entry for the purposes of the Promotion.

General terms and conditions

- 6. No responsibility will be accepted for late, lost, incomplete or misdirected Entries. The Promoter reserves the right in its sole discretion to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such a person are reserved.
 - a. Proof of identity will be required to claim any prize.
 - b. If any Winner is under 18 years of age, the Prize will be awarded to the Winner's nominated parent/guardian upon presentation of photo identification. The parent/guardian shall be deemed the Winner for the purposes of these terms and conditions.
