TERMS & CONDITIONS

1. 'Find Santa's Reindeer' (Promotion) commences at 9.00am AEDT on Saturday 29 November 2025 and concludes at 11.45pm AEDT on Tuesday 23 December 2025 (Promotion Period).
2. The Promotion is delivered by Launceston Central Inc. (Promoter) Suite 1, Level 1, 7-11 Quadrant Mall, Launceston, Tasmania.
3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

COMPETITION DETAILS

4. 'Find Santa's Reindeer' invites members of the public to search for the nine (9) reindeer decals, displayed in the windows of participating businesses located within the Launceston Central Core Services Area.

HOW TO PARTICIPATE

5. To participate the Promotion, Entrants must, during the Promotion Period:
 - a) Find at least three (3) and up to nine (9) reindeer decals displayed in the windows of participating businesses, located in the Launceston Central Core Service Area; and
 - b) Access the digital entry form available from launcestoncentral.com.au/christmas/find-santas-reindeer; and
 - c) Complete a digital entry form with the names of at least three (3) of the lost reindeer and the correct name of the shop/business window where each of them was found.
 - d) Provide their full name and contact details and agree to be subscribed to the Promoter's digital newsletter.
