

# CHRISTMAS WINDOW COMPETITION 2025 TERMS & CONDITIONS

- 1. 'Light Up Launnie' (Promotion) commences at 9.00am AEDT on Saturday 29 November 2025 and concludes at 11.45pm AEDT on Sunday 21 December 2025 (Promotion Period).
- 2. The Promotion is delivered by Launceston Central Inc. (Promoter) Suite 1, Level 1, 7-11 Quadrant Mall, Launceston, Tasmania.
- 3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

### **COMPETITION DETAILS**

- 4. 'Light Up Launnie' invites businesses located within the Launceston Central Core Services Area to decorate their shopfronts with Christmas-themed window displays.
- 5. The Promotion also invites members of the public to follow a trail map to view the decorated windows and vote for their favourite.
- 6. Prizes will be awarded to the Business Entrant receiving the most public votes, and to one, randomly selected, public Voting Entrant.

### **HOW TO ENTER**

- 7. To enter the Promotion, Business Entrants must, prior the Promotion Period and within the deadlines specified by Launceston Central:
  - a) Register their participation in the Promotion with Launceston Central; and
  - b) Decorate their shopfront / business window in a Christmas theme.
- 8. To enter the Promotion, Voting Entrants must, during the Promotion Period:
  - a) Vote for the best Christmas window display, via the online voting form; and
  - b) Provide their full name and contact details and agree to be subscribed to the Promoter's digital newsletter.
- 9. All Entrants are responsible for ensuring their Entry is submitted and valid.
- 10. Voting entries to the Promotion are limited to one per person.
- 11. Voting entries can be made up until 11.45pm on Sunday 21 December 2025.

## WINNERS AND PRIZES

- 12. The Voting Entrant Prize will be drawn after the conclusion of the Promotion, on Monday 22 December 2025.
  - a) The Winning Voting Entrant will be selected at random by a staff member of the Promoter and the Entry must abide by Terms and Conditions to be eligible.
  - b) A single Prize will be awarded for the Winning Voting Entrant consisting of a voucher to the value of \$250 to a store of their choice, to be selected from the businesses listed on the Launceston Central website.
  - c) The Prize must be used in conjunction with the Terms and Conditions set out in the voucher selected and cannot be redeemed for cash.
  - d) The Winning Voting Entrant will be advised by phone and/or email on the day of the draw and will be able to collect their Prize from the Promoter when business resumes on or after Monday 5 January 2026.



- e) The Winning Voting Entrant will have until Friday 27 February 2026 to collect their Prize, after which time it will be forfeit.
- 13. The Business Entrant Prize will be drawn after the conclusion of the Promotion, on Monday 22 December 2025.
  - f) The Winning Business Entrant will be determined by the most number of public votes received via the online entry form and the Entry must abide by Terms and Conditions to be eligible.
  - g) A single prize will be awarded for the Winning Business Entrant consisting of a radio advertising campaign with Chilli FM, valued at \$1,500.
  - h) The Prize must be used in conjunction with the Terms and Conditions set out in the voucher selected and cannot be redeemed for cash.
  - i) The Winning Business Entrant will be advised by phone and/or email on the day of the draw and will be able to collect their Prize from the Promoter when business resumes on or after Monday 5 January 2026.
  - j) The Winning Business Entrant will have until Friday 27 February 2026 to collect their Prize, after which time it will be forfeit.

- 14. No responsibility will be accepted for late, lost, incomplete, or misdirected Entries. Entries containing incorrect contact details shall be deemed invalid.
- 15. The Promoter reserves the right, in its sole discretion, to disqualify any Entrant whom the Promoter has reason to believe has breached any of these Terms and Conditions or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such a person are reserved.
- 16. The Promotor's decision is final.
- 17. Proof of identity will be required to claim any Prize.
- 18. If any Winner is under 18 years of age, the Prize will be awarded to the Winner's nominated parent/guardian upon presentation of photo identification. The parent/guardian shall be deemed the Winner for the purposes of these terms and conditions.
- 19. All Entrants under the age of 18 must have prior consent from their parent or guardian before entering the Promotion and must be able to provide evidence of such consent on request.
- 20. By entering the Promotion, the Entrant hereby:
  - a) Agrees to the terms and conditions; and
  - b) Gives the Promoter authority to publicly announce their name (should they be a Winner) at the time of the selection and at any stage thereafter; and
  - c) Gives their consent to receive future marketing communications from the Promoter. This consent may be withdrawn at any time by unsubscribing.
