

## SLICE-A-LICIOUS 2025 TERMS & CONDITIONS

- 1. 'Slice-a-licious' (Promotion) commences at 7.00am AEST on Monday 18 August 2025 and concludes at 11.59pm AEST on Sunday 31 August 2025 (Promotion Period).
- 2. The Promotion is delivered by Launceston Central Inc. (Promoter) Suite 1, Level 1, 7-11 Quadrant Mall, Launceston, Tasmania.
- 3. All Entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

## THE PRIZE

- 4. A single prize will be awarded for the Winning Voter, consisting of:
  - a) One (1) \$200 voucher for any venue listed under the 'Eat & Drink' category on the Launceston Central website, www.launcestoncentral.com.au. The Prize is sponsored by the Promoter.
- 5. The Prize will be drawn after the conclusion of the Promotion, on or after Monday 1 September 2025.
- 6. The Winning Voter will be selected at random by a staff member of the Promoter and the Entry must abide by Terms and Conditions to be eligible.
