



## **SOUPALICIOUS 2024 TERMS & CONDITIONS**

1. 'Soupalicious' (Promotion) commences at 9.00am AEST on Thursday 1 August 2024 and concludes at 11.59pm AEST on Saturday 31 August 2024 (Promotion Period).
2. The promotion is promoted by Launceston Central Inc. (Promoter) Level 1, 63 – 65 Cameron Street in Launceston, Tasmania.
3. All entrants will be subject to, and will need to adhere to, the Terms and Conditions as set by the Promoter and any future Terms and Conditions amended.

### **THE PRIZE**

4. Prizes will be awarded for the Winning Venue and the Winning Voter.
5. The Prize for the Winning Venue consists of:
  - a) A professional photography/videography session with Sileo Media valued at \$500, including:
    - One (1) 30-minute consultation prior to the shoot, to plan out the day; and
    - One (1) three-hour photography/videography shoot at the Winning Venue's place of business; and

8. The Winning Voter will be selected at random by a staff member of the Promoter and the entry must abide by Terms and Conditions to be eligible.
9. The Winning Venue will be awarded to the venue with the greatest number of public votes for its Soupalicious offer and the entry must abide by Terms and Conditions to be eligible.
10. The Winners will be advised by phone and/or email on the day of the draw and will have 14 days to collect their Prize from the Promoter.
11. The Prizes must be used in conjunction with the Terms and Conditions set out in the individual vouchers selected and/or by the service providers and cannot be redeemed for cash.

12. To enter the Promotion, Venue Entrants must, during the Promotion Period:
  - a) Create a soup flavour that is available for purchase for the entire duration of the Promotion Period; and
  - b) Submit that offer to, and have it accepted by, the Promoter as a valid Soupalicious entry.
13. To enter the Promotion, Voting Entrants must, during the Promotion Period:
  - a) Vote for a competing Venue Entrant via the online voting form; and
  - b) Provide their contact details and agree to be subscribed to the Promoter's digital newsletter.
14. The Entrant is responsible for ensuring their Entry is submitted and valid.

15. No responsibility will be accepted for late, lost, incomplete or misdirected Entries. Entries containing incorrect contact details shall be deemed invalid.

The Promoter reserves the right, in its sole discretion, to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such a person are reserved.
